

Answer For Boat Company Is Due On Friday, July 27

The Board of Directors of Pulaski Industries, Inc. and the members of the Board of Directors of the Chamber of Commerce will again meet next Wednesday evening, July 25 at 8:00 p.m. at the high school gym for the purpose of making a final decision on the question of accepting the boat company's offer of establishing their manufacturing department at Pulaski. The committee will also check on the progress made thus far toward the raising of \$50,000 needed for the project. The balance of the money needed for the construction of the Shoe Factory addition as well as the boat factory could be borrowed from the bank, but the first \$50,000 must be sold by Pulaski Industries, Inc. as shares in stocks and bonds.

At the last meeting held on July 18, the Board of Directors decided on several important items. All members present unanimously voted to make an attempt to raise the necessary finances. Everyone agreed that this is a fine chance for the community to get another industry which will diversify jobs and which will give work in the wintertime. Most of the members present stated that since Pulaski was looking for another industry for the last five or six years, we should take advantage of this opportunity since the boat company people are now willing to come in. "It's no use talking about attracting industry to the area and then refuse to take it when we have the chance," was a comment heard over and over again at the meeting.

The Board of Directors of the Pulaski Chamber of Commerce voted to aid the industry by engaging Ed Johnson as promotion manager. Ed is well known in these parts and he will have the job of contacting businessmen, farmers and all individuals that may be interested in supporting the project. Anyone that is willing to invest any money in Pulaski Industries, Inc. is advised to see Ed Johnson within the next ten days for the purpose of getting a full explanation of the boat factory proposition. It was also decided that anyone who cares to invest may deposit his money at the Pulaski State Bank where it will be held in trust for the purpose of building factories this fall. One important decision was that any money deposited will start to bear 5% interest from the day it is
